## 95X LABATT BLUE/BLUE LIGHT SEA DOO GIVEAWAY OFFICIAL RULES

The Station will conduct the **95X Labatt Loving Summer Sea Doo Giveaway** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
  - Eligibility. All entries must be received by the deadline stated at the remote broadcast.

4. Winner Selection. Listeners will be permitted to complete one entry form per remote broadcast. At the end of each of the remotes (a) through (h), ten (10) qualifiers will be chosen by random drawing to be entered in the Grand Prize drawing. In addition, at 8pm July 12, 2018, fifteen (15) qualifiers will be chosen by -random drawing to be entered in the Grand Prize drawing.

At 8:00pm ET on July 12, 2018, 95 qualifiers <u>must</u> attend in person at Borio's Restaurant, 8891 McDonnells Pkwy, Cicero NY for a chance to win the Grand Prize (as defined below). Each qualifier in attendance will be given a number (1-95, or lessor amount if qualifiers not in attendance) as they check in to the final event.
